Based on preliminary review on the management accounts of the Group, the board of directors of the Company (the "Board") wishes to inform shareholders of the Company (the "Shareholders") and potential investors that the Group is expected to record a significant increase in the operating profit for the financial year ended 31 December 2010 as compared to that for the last financial year ended 31 December 2009. Such increase in operating profit was mainly a result of the expansion of the Group's retail networks as well as the increase in same store sales of its existing retail outlets.

However, the net profit of the Group for the year ended 31 December 2010 is expected to be substantially reduced by the fair value adjustments of the convertible bonds and warrants issued by the Group. Since the fair value adjustments are non-cash nature and non-related to business operation, it would not have any impact on the financial position of the Group. The Board considers that in order to have more fairly assessment on the results of the business operation of the Group, Shareholders and potential investors should exclude such non-cash adjustments when considering the financial results of the Group.

The relevant amount of the aforesaid adjustments is not yet finalized and therefore, the exact impact on the net profit of the Group is yet to be ascertained. The Company is still in the process of finalising its audited annual results for the year ended 31 December 2010. This announcement is made based on the preliminary assessment of the unaudited management accounts of the Group and the information currently available. Details of the Group's performance will be disclosed in the annual results announcement which is expected to be released by end of March 2011.
